**Michigan Colored Pencil 2022 is a 100% colored pencil art exhibition, open to all members of CPSA, CPSA Detroit District Chapter #104, and all Michigan and northern Ohio artists.**

### Eligibility:

Artist must be 18 or over. Artists may submit up to three (3) 2-dimensional original works of art, **completed within the last three years**, that have not been shown previously in any "Michigan Colored Pencil" exhibit.

### Artwork Specifications:

**Media must be 100% colored pencil on a manufacturer-prepared surface** (scratchboard not allowed). Acceptable colored pencil products can be found at [www.cpsa.org](http://www.cpsa.org) on "Show Requirements" under the Shows/Events tab.

\*Must be **100% colored pencil** and each artwork cannot exceed 32"x 40" framed.

\***Each artwork must have Plexiglas (acrylic) with a hook and eye/wire hanger** (NO sawtooth hangers). Any artwork with glass and or sawtooth hangers will be rejected.

\***Artwork must be 2 dimensional.** No collage or montage.

**Concept, design, and execution of the artwork shall be solely that of the artist:** No work copied from copyrighted or published materials is allowed. No images produced by drawing over a digital reproduction are allowed and no work copied from someone else's photograph—even with permission is allowed.

### Entry Fees:

Entry fees are \$10.00 per picture for up to three (3) pieces entered for CPSA members and \$15.00 per picture for up to three (3) pieces for non-CPSA members. Fees are due with entry form and jpeg image(s) by the deadline, postmarked by August 29, 2022. **Email jpegs to Diane at [rradtke01@comcast.net](mailto:rradtke01@comcast.net).**

### Liability:

Artists are responsible for insuring their own artwork. CPSA#104 takes every precaution to protect all artwork; however, the Plymouth Community Arts Council and CPSA **will not** be responsible for artwork received in damaged condition or in the event of loss or damage to artwork submitted to this exhibit.

### Artwork Identification:

Each artwork must be identified on the back (top right corner) by Artist, Artist's phone number, Title, and Pricing. NFS works must indicate value.

**Sale of Artwork**

Prices will be marked (or NFS plus a stated value) on artworks. The Plymouth Community Arts Council will collect a **30% commission**. All artwork must remain for the duration of the exhibition.

**Selection of Submitted Artwork**

Emails notifying artists of works accepted or declined will be sent by October 8 and will be posted on the chapter website, [www.cpsadetroit.com](http://www.cpsadetroit.com). Shipping information will be supplied at that time.
